2. The officers who are debarred under the CSS are not eligible to be considered. The officers once sponsored will not be allowed to withdraw subsequently. <u>It is not only the failure to take up the appointment, but also withdrawal after a panel has been recommended by the Department that leads to debarment for 5 years.</u> In the event of selection, If an officer does not join within one month of issue of his appointment order, his appointment would be treated as cancelled and the officer concerned would stand debarred from Central deputation for a period of five years from the date of issuing orders of his debartment. Further, he would also be debarred from being considered for any foreign training as also from being given cadre clearance for being deputed on foreign assignments/consultancies abroad during the period of debarment.

3. The initial deputation tenure in the post of CVO is **three years** in the PSU extendable upto a further period of 2 years in the same PSU (**total max. five years**) with the concurrence of the CVC or upto a further period of three years on transfer to another PSU on completion of initial period of three years in the previous PSU (**total max. six years**) with concurrence of the CVC and approval of the Competent Authority. The officers would be considered for posting in any PSU in a particular location and preferences given by individual officers for a particular PSU in a particular location and officers will remain under consideration for posting for a period of one calendar year only.

4. Officers should be at least in the pay scale of Rs. 18400-22400/-. The officers on deputation as CVOs in Central PSUs will not be entitled to the general pool accommodation but would be eligible for accommodation provided by the concerned PSU.

5. Eligible officers, who are willing to be considered for the above post(s), may please send their willingness along with their service particulars (in the format given below except columns 4 to 6 & 9) and complete service profile duly signed (please refer column 10 of the proforma) by email to the undersigned at <u>narainD@cag.gov.in</u> immediately and <u>not later than 10.2.2006</u>. Requests for appointment as CVO, from the officers occupying a post under the CSS on deputation basis, duly recommended by the Ministry/Department, with the approval of the Minister-in-charge, should be ent at least one year before the expiry of his/her tenure on the CSS post.
